PAYMENT OF PAST DUES -UPDATE

Hello homeowners! We wanted to quickly remind you all that the dues deadline was October 1, 2023. According to our records, many of you have forgotten to send in the \$125 dues. Reminder letters have been sent to those who may have forgotten. For those that are multiple years in the rears, Certified -30 day - Notice of Late Assessment letters were mailed on Tuesday, 28TH of May. In total there is approximately, \$29, 000.00 owed in back dues. It is imperative that this money is collected

The Association has been advised by its legal counsel, while the River Country Estates Owners' Association, Inc. deed restrictions may not have lien rights for the assessments, the corporate Association continues to exist and has obligations to maintain the common areas. As such, as a member/share-holder, the owners of property within the Association remains obligated to pay their share of the common expenses of the corporation as would the shareholders of any other corporation. That is general corporate law. Moreover, under the law of contracts, the Declaration is a contract to which the parties remain obligated regardless of whether same is an encumbrance on the real property. Contract law does not require a real covenant or equitable servitude for a contract to be enforceable against the parties to the contract. Finally, under a common law theory of unjust enrichment, you are receiving the benefit of the actions of the Association, and you cannot do so without paying your fair share of the expenses.

Please follow by the instructions in the letters to prevent further actions and additional cost to the association. If you have specific questions about your account, please stop by the office to schedule an appointment with the President and Treasure

Thanks to the owners who have made the effort to get caught up with their assessments, however there are still over 80 homes that still have an outstanding balance. Per Florida Statute 720.305 (4), An association may suspend the voting rights of a parcel or member for the nonpayment of any fee, fine, or other monetary obligation due to the association that is more than 90 days delinquent. This will occur at the July board meeting for those who have not complied. The suspension ends upon full payment of all obligations currently due or over due to the association.

DEED RESTRICTIONS REMINDER

G. MAINTENANCE

All dwellings, structures, driveways, fences and parts thereof shall be maintained in a condition as near to new as reasonably possible. Painting, repairs and replacements shall be made as they become necessary or when the dwelling, structure or fence is no longer in harmony with River Country Estates community. When repainting in a different color, an official RCEOA Application for Architectural Approval shall be submitted to the DRAC for approval.

3. Maintenance

- a. Lot owners are required to maintain the appearance of their landscaping. Lawns, beds or islands shall have no area of dead plant material visible. All landscaping shall be kept in harmony with the River County Estates community. No front lawn shall have bare areas, and shall be maintained and moved to the street.
- b. On developed lots, grass higher than 10" or weeds higher than 12" shall be considered unacceptable. If the property owner does not respond within seven (7) days of receipt of written notification, the RCEOA will have the option to have the lawn cut and the owner billed for the cost plus any other expenses incurred and deemed proper by the RCEAO.
- c. Trees and limbs on vacant lots determined by the DRAC to be an eyesore or hazard, will be brought to the attention of the lot owner. Should the lot owner fail to take action within seven (7) days of receipt of notification, the RCEOA will have the option of correcting the problem and billing the owner for the expense.

3. Maintenance


Maintenance of all structures shall be required in Section 3 paragraph G, and grounds shall be kept clear of dead limbs, vines, trash and rubbish, with palnts, grass and other growing features trimmed neatly to conform to the general high standards of River Country Estates.






Spring Hill has a population that is exploding. Numerous apartment complexes are being built in our area. These are very large and will house four to five hundred occupants each. This will pose a logistical challenge as far as traffic is concerned as well as a possible increase in crime. The Sheriff reports that they are underway to realign districts, request new deputies, and generally look at the overall scope of operation to respond to this dramatic increase in population. More and more people are having to turn to renting as the price of housing increases, so this trend is not likely to go away anytime soon.

The main complaint from our residents is speeding on River Country Dr., Floral, and Delaware. It is unlikely that you will be able to get a license number, so please note the time of day, description of vehicle and occupants and get that info to me so we can request extra patrol. Do not confront or follow these vehicles for your own safety. Currently we have reports on a small silver or gray vehicle speeding on River Country as well as Floral. If you have info on this vehicle call me.
